This Memorandum of Understanding (MOU) is entered into on this 28th day of January, 2023 for a period of five years by Mangolnganbi College, Ningthoukhong C.I. College, Bishnupur, Moirang College, Moirang, Nambol L. Sanoi College, Nambol, Mayai Lambi College, Yumnam Huidrom, Kumbi College, Kumbi, S. Kula Women's College, Nambol and Pravabati College, Mayang Imphal and agreed to extend cooperation in research collaborations and student and faculty exchanges that would be mutually beneficial. The areas of cooperation may include, subject to mutual consent, any desirable and feasible activity that would promote the goals of each institution. Such interaction may include cooperation in a variety of joint academic and educational activities such as:

- To conduct annual mid-winter waterbird census and research in Loktak Lake as social and scientific responsibility to conserve and protect this wetland of international importance as the colleges are in the vicinity and around the Loktak Lake in collaboration with Indian Bird Conservation Network (IBCN) under Bombay Natural History Society (BNHS), Mumbai.
- To create a mutual corpus fund.
- Joint research projects and publications, including work by undergraduate students, teachers at the partner institutions.
- To seek fund for research.
- Faculty and student exchanges based on reciprocity.
- Joint conferences, seminars, and workshops.
- Team taught courses, including online courses.
- Visits by the faculty, professional staff, and students.

The parties anticipate that a number of these initiatives will occur during the period of this MOU. However, neither party is obligated to agree to any minimum number of activities, nor is this MOU intended to preclude either party from entering into similar agreements with other institutions.

This MOU shall be identified as the parent document of any program agreement executed between the parties. Further agreements concerning any program shall provide details concerning the specific commitments made by each party and shall not become effective until they have been reduced to writing, executed by the duly authorized representatives of the parties.



1. Objectives of MOU

In order to promote co-operation and collaboration between **Pravabati College, Mayang Imphal, Manipur** and **Mangolnganbi College, Ningthoukhong Manipur** situated Bishnupur District of Manipur this MOU aims to carry out the following objectives:

- a) To promote and enhance academic interest between the institutes.
- b) To exchange the expertise's of the institutions mutually.
- c) To promote exchange of students and research activities between the institutes.
- d) To encourage direct contact and cooperation's between their faculty and students in different departments particularly in the following disciplines:
- e) To promote cultural exchange programs.

 - Commerce
 - Sports
 - Education
 - English
 - Earth Sciences

- Political Science
- All the Science Department

2. Technical Area of collaboration

- a) Provide academic interactions by delivering special lectures at Pravabati College and Mangolnganbi College.
- b) Exchange of scientific and technological information, joint publications of common results.
- c) To exchange the visiting international delegates to each institutes mutually.
- d) Identify and invite the faculty members and researchers from other institutes to participate in conference, workshops, and short-term courses.

Both institutes recognize each other's legal capacity to sign this agreement and

Declare that:

Pravabati College, Mayang Imphal and Mangolnganbi College, Ningthoukhong Manipur manifest their intension to search an agreement to foster academic cooperation according to the following terms and conditions:

Article 1. Pravabati College, Mayang Imphal and Mangolnganbi College, Ningthoukhong Manipur agree to promote joint teaching, research and other academic activities as aforesaid in the objectives and technical area of collaboration for mutual benefit to both institutes.

A specific plan and agreement will be worked out and approved by the institutes before any such programs or activities can be undertaken.

Article 2. Resources for the implementation of specific programs may derive from either party or from external funds. However, this agreement does not oblige either party to expand any resources in connection with the objectives herein specified unless explicitly stated otherwise in the corresponding specific agreement.

Article 3. The agreement will be effective for a period of five years from the date of its signing and the renovation will be required for the period unless otherwise specified by the signing institutions.


Article 4. This agreement doesn't imply any financial duty upon both the institutions.

Article 5. Either party may terminate this agreement on written notification. Such notification must be given at least six months prior to the proposed date of termination. Article 6. Each institution appoints a coordinator for the implementation of this agreement, who will be responsible for defining and organizing the programs to be undertaken and for interaction between the two institutions.

Article 7. The intellectual property right (IPR) that arise as a result of joint research and collaborative activity under the agreement will be worked out on a case basis and will be consistent with officially laid down IPR policies of the two institutes.


